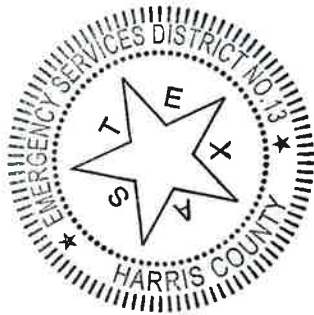
The District will consider and act upon the following matters:

6. To review, discuss and take action regarding any needed repairs or improvements related to the operation of the District fire stations or equipment.

8. To discuss, review, and approve actions necessary for provision of EMS services in conjunction with Harris County ESD No. 11.
9. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
