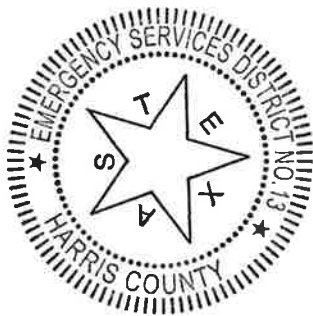
The District will consider and act upon the following matters:
