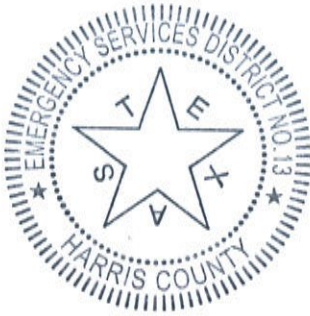
The District will consider and act upon the following matters:

1. Call meeting to order.

3. To receive any reports from Fire Chief Richard Lieder and take any necessary action related to his report.
4. To receive any administrative reports from the District Staff.
5. To review, discuss and take action regarding any needed repairs or improvements related to the operation of the District fire stations or equipment.
6. To review, discuss, and take action on dispatch services.
7. To discuss, review, and approve actions necessary for provision of EMS services in conjunction with Harris County ESD No. 11.
8. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
  - a. Chairs from Station 22 and Station 24 training rooms.
  - b. 2 metal cabinets.
9. Review, discuss, and approve purchase of Class A uniform belt, pants, and shoes for all personnel.
10. To review, discuss and approve upcoming Purchase Orders.
11. To review and take action on granting exemptions for 2022.
12. To pay District bills, ACH withdrawals and transfers for payroll as well as any other checks that are presented at the meeting.
13. To receive the Treasurers' report for the District and take any action related thereto.
14. To review and approve the District's April 2022 Financial Statement.
15. To consider approval of the minutes from the meeting held on April 25, 2022.
16. To review, update, and approve District and personnel matters and policies.
  - a. Increase volunteer stipend amount to \$45 per shift and increase the monthly volunteer stipend cap to \$900.
17. To review, discuss and take action on any District matters which need to be included on the June 2022 meeting agenda.
